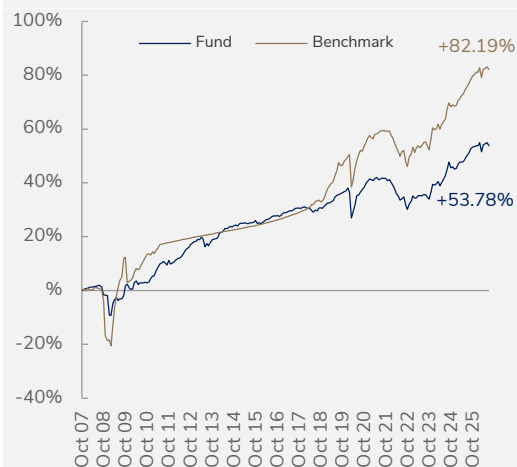

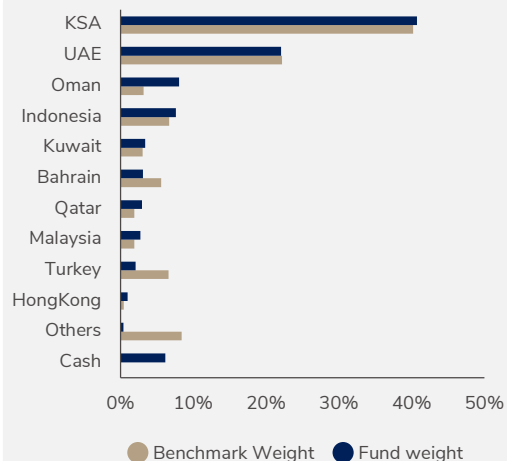

Country allocation

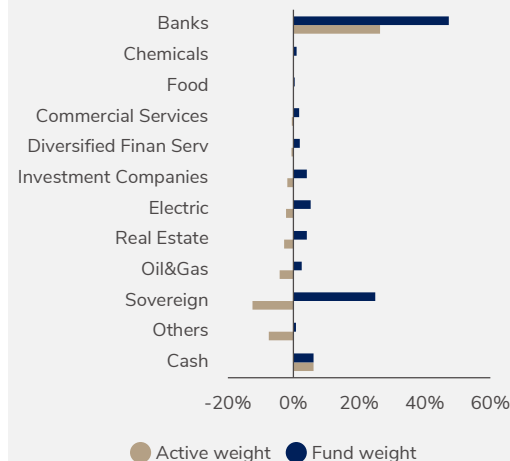

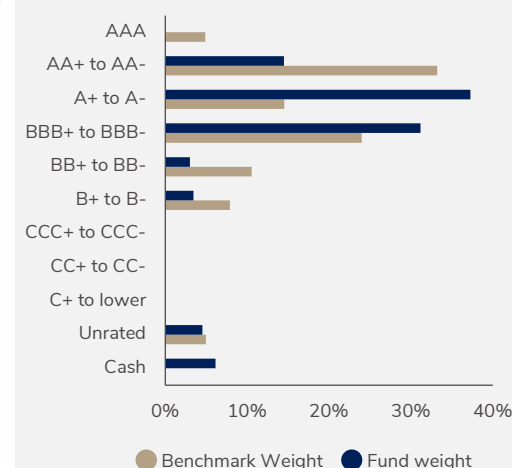
